 - Each statement of defence shall respond to (b), (c) and (d).
- 6.2 The Arbitrator shall decide the time limits for submission of the pleadings mentioned in Clause 6.1, and shall determine the rules of procedure to the extent that they are not laid down in this Agreement.
- 6.3 The parties may add to or amend their pleadings only with the prior consent of the Arbitrator.
- 6.4 Copies of all written pleadings shall simultaneously be made available by the party issuing the pleadings to both the other parties to this Agreement as well as the Arbitrator.




